Beyond compliance with applicable legislation and internal instructions, we define, track and review the internal objectives for our company on an annual basis.

Our integrated management system prescribes continuous improvement in quality, safety, environmental protection, occupational health & safety and energy efficiency, in addition to binding documentation of organisation, regulations and evidence. The effectiveness of this system is regularly reviewed by internal and external auditors, and the improvement opportunities they identify are implemented.

Human health and the protection of the environment take precedence over other objectives in the risk assessment of hazards that could arise during the manufacture, storage and transport of our products.

We attach great importance to protecting the data of our employees, as well as our dialogue and business partners. To this end, the GDPR provides us with a framework, which we supplement, where appropriate or desired, with corresponding binding agreements, thus ensuring the legitimate interests of all parties involved with regard to data protection.
